The Parishes of Barlow and Dronfield - The Big Dipper Half Marathon

Temporary Rolling Road Closure Order (No. 11) 2023

WHEREAS North East Derbyshire District Council being the local authority for the Parishes of Barlow and Dronfield having been informed of an anticipated or likely obstruction of streets within the Parishes of Barlow and Dronfield is satisfied that all traffic and pedestrians should be prohibited and prevented from using roads or streets on the date set out below in order to prevent an obstruction or obstructions occurring.

1 North East Derbyshire District Council in exercise of the above and all other powers conferred on it by statute in this respect hereby makes the following Order :-

(a) No person shall on 10th September 2023 cause or permit any vehicles to pass along part of Hilltop Road, part of Gosforth Lane, Barlow Lees Lane, part of Brindwoodgate, part of Crow Hole, part of Valley Road, Far Lane, Unthank Lane, Fox Lane, Dobbin Lane, and part of Cowley Lane in the Parishes of Barlow and Dronfield between the hours of 9.30am (09:30 hours) and ~~4:00pm~~ (13:45 hours) on a rolling/managed basis shown in red on the attached plan or along any part of such streets or roads specified in this Order.

(b) The provisions of (a) above shall only apply during such times and to such extent as shall from time to time be indicated by traffic signs or otherwise upon the direction or with the permission of a trained marshal or steward or a Police Constable in uniform.

(c) None of the foregoing provisions shall apply to any vehicle being used by or on behalf of the Police Fire Brigade or Ambulance Services.

2 This Order may be cited as The Parishes of Barlow and Dronfield Temporary Street Closure Order and shall be effective on 10th September 2023 only.

3 North East Derbyshire District Council hereby directs the marshals, stewards or constables stationed at the approaches to the roads and streets the subject of this Order to take all and any steps as in their discretion are necessary to keep order and to prevent the roads or streets being obstructed including if and where necessary the total closure of the said roads and streets but subject to the provisions of 1 (c) above.

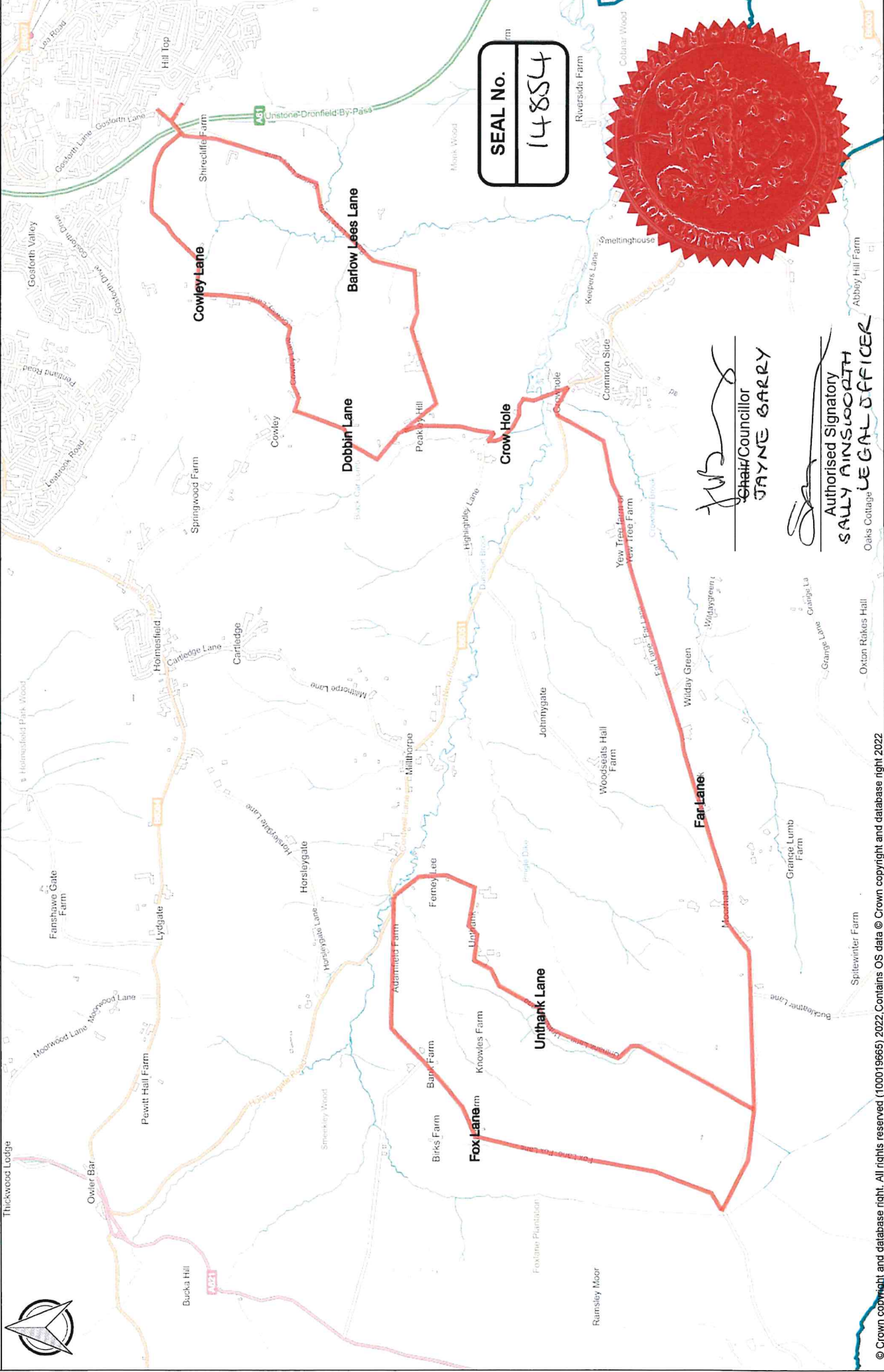
